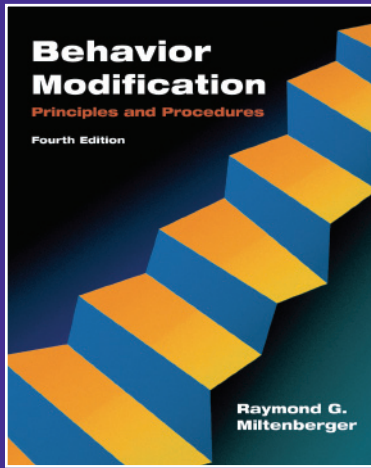

NEW TO THIS EDITION

- ▶ **Directed Reading Boxes!** The chapters on behavioral principles (Chapters 4-8) and procedures (Chapters 9-25) now each include a **Directed Reading Feature**. In this feature, one or more interesting articles relevant to the content of the chapter are identified, briefly described, and citations provided. These articles are from JABA (or JEAB) so they can be easily accessed online by students (The JABA website is <http://seab.envmed.rochester.edu/jaba/>). Instructors can assign these articles for extra credit or when more advanced students are using the textbook.
- ▶ **List of New Terms.** Each chapter now begins with a list of new terms, which includes definitions of all the new terms used in that chapter. Although these terms are all found in the Glossary at the end of the text, with the new terms identified and defined at the beginning of each chapter, students can make easy reference to the terms when reading the chapter or when studying for a test or quiz.
- ▶ **Updated and Expanded References.** The Fourth Edition includes 125 additional references, many from the most recent volumes of JABA, giving students the most recent scholarship in the field.

▶ **New Updates.** Chapter 1, “Measurement of Behavior and Behavior Change,” includes a brief discussion of the relationship between applied behavior analysis and behavior modification. Chapter 2, “Observing and Recording Behavior,” has new information on structured versus unstructured assessment and on recording percentage of opportunities. Chapter 4, “Reinforcements,” includes a new discussion of social versus automatic reinforcement. Chapter 12, “Behavioral Skills Training Procedures,” has a new section on in situ training, a method to increase generalization following the use of BST. Chapter 16, “Antecedent Manipulations,” includes new chapter headings to help readers organize the research. In Chapter 19, “Promoting Generalization,” a new figure and text has been added (Durand, 1999) to highlight a more recent study on programming generalization.
